YOUNG ADULT AND CHILDREN VOLUNTEER INFORMATION
CLEARANCE REQUIREMENTS AND INSTRUCTIONS**



VOLUNTEER CLEARANCE REQUIREMENTS

In accordance with Pennsylvania State Law, **all volunteers shall obtain clearances** if they:

- Are **responsible for the welfare of a child** (acting in lieu of or on behalf of a parent) **OR**
- Have **direct volunteer contact** (provides care, supervision, guidance or control on a regular/repeated basis which is integral to the volunteer responsibilities) **with children under the age of 18**

This state law is inclusive of church volunteers. The clearances shall be current and must be updated every 5 years (60 months) from the date of the oldest clearance. **It is Good Shepherd's policy that a volunteer's clearances be obtained prior to working with the children and youth, and the clearance certificates shall be provided to the Church Office to be kept on file.**

The following clearances shall be obtained:

1. Pennsylvania State Police Criminal Record Check – all volunteers
2. Pennsylvania Child Abuse History Clearance – all volunteers
3. FBI Criminal History Clearance – **only if** the volunteer has resided in Pennsylvania for less than 10 years **or** has been convicted of a disqualifying offense (see waiver for this list). Otherwise, a waiver may be signed.

COST AND HOW TO OBTAIN THE CLEARANCES

Pennsylvania State Police Criminal Record Check

- This clearance is free to volunteers.
- Results are often received immediately when applied for online. Applicants may then view and print their results.

Pennsylvania Child Abuse History Clearance

- This clearance is free to volunteers when requested one time within 57 months.
- The results are generally received electronically within two weeks (14 days) when applied for online. Applicants may then view and print their results.

FBI Criminal History Clearance

- Volunteers currently pay a fee of \$23.25 for this clearance check (as of 5/2/2023)
- The applicant must register prior to going to the fingerprint site. Registration may be done online at <https://uenroll.identogo.com> or you may call 1-844-321-2101.

- The service code for all volunteers is 1KG6ZJ (DHS Volunteer). All volunteer services are included within this code. It is titled “DHS” because it is a Department of Human Services Child Protective Services Law requirement.
- Once you register, you have 90 days from the registration date to go to one of the fingerprint locations to get your fingerprints. To see a list of approved fingerprint locations, please visit <https://www.identogo.com/locations>. You may walk-in to a location’s posted hours of operation, but it is recommended you schedule an appointment for the fingerprinting to lessen your wait time. It may take up to 2 weeks to get that appointment scheduled.
- The results from this clearance are generally received within two weeks (14 days) after the actual fingerprinting via a paper copy mailed to your home.

The FBI Clearance is NOT needed if the volunteer has been a resident of the state of Pennsylvania for the entirety of the last 10 years AND the volunteer has never been convicted of a disqualifying offense. In this case, the volunteer is exempt from the FBI clearance and shall complete the attached Children and Youth Volunteer Affirmation Waiver form.

**VOLUNTEER REQUEST FOR WAIVER OF
FBI – FEDERAL CRIMINAL HISTORY CLEARANCE**

I declare under penalty of perjury that the following is true and correct:

1. I have been a resident of the Commonwealth of Pennsylvania during the **entirety of the previous ten-year period** from the date of this document;
2. I have **NEVER** been named the perpetrator of a founded report of child abuse;
3. I have **NEVER** been convicted of one or more of the following types of offenses, including the attempt, solicitation or conspiracy to commit any of the following offenses:
 - a. Criminal homicide
 - b. Aggravated assault
 - c. Stalking
 - d. Kidnapping
 - e. Unlawful Restraint
 - f. Rape
 - g. Statutory sexual assault
 - h. Sexual assault
 - i. Involuntary deviate sexual intercourse
 - k. Indecent assault
 - l. Indecent exposure
 - m. Incest
 - n. Concealing the death of a child
 - o. Endangering the welfare of a child
 - p. Dealing in infant children
 - q. Prostitution and related offenses
 - r. Crimes related to obscene and other sexual materials and performances
 - s. Corruption of minors
 - t. Sexual abuse of children
4. Within a 5-year period immediately preceding the date of this document, I have not been convicted of a felony offense under The Controlled Substance, Drug, Device and Cosmetic Act; AND
5. I have not been convicted of an offense similar in nature to those crimes listed under paragraphs 2, 3, or 4 above under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former Pennsylvania law.

I understand that statements herein are made subject to the penalties of 18 Pa. C.S. § 4904 relating to unsworn falsification to authorities.
